c. Sponsorship & Endorsements

- -There is nothing in the constitution that says we can sponsor or endorse.
- -would you like to sponsor of endorse?
- -Endorsing: Getting request from people running for campaigns, they ask us whether or not we as a space find this individual or measure to be representative of the college. In doing so we give them credibility to be on the ballot to show Merrill College agrees with them.

Q: do we have to advertise for them?

A: There is going to be measure 66 and pertains a lot to us, student govern spaces and it is a fee that we currently pay between Opers and Spaces. If you remember in fall quarter SUGB brought up resolution to separate from Opers. There are resolutions coming from Opers and Student Govern spaces. Up to us if we want to advertise for them.

- **Sponsorship**: funding for a campaign to continue
- **Itai:** I don't think that we should sponsor or endorse anyone. And if we do it should be super majority.
- **Kimberly:** I am not in favor of it too much. I feel like it gives us too much influence over us in the Merrill Community. Trying to represent all of Merrill and I can't say that we do. Puts a lot of pressure on other people, and too much power of us.
- Marin: I don't like either of them. But I like when they come to the space and talk to us. That way we can better inform the voters.
- **Bee:** I was against it becomes our job as a body is have a voice for the students. But I think that it is a good idea to show the opinion of the group in the space. MSG is actually involved in these actions. It wouldn't necessarily be a negative thing.
- Victor: We can say Merrill student government does but not the population of Merrill College supports...
- Lily: I think it is a good idea to educate/inform our community in an unbiased work.
